# The National Council for Human Rights NCHR inaugurates the fifteenth forum of civil society organizations

The National Council for Human Rights (NCHR)inaugurated on January 17<sup>th</sup> its fifteenth Annual Civil Society Organisations CSO's Forum for Human Rights for the year 2023 at the headquarters of NCHR in the presence of Nevin Al-Qabbaj, Minister of Social Solidarity, MP. Tariq Radwan, Chairman of the Human Rights Committee, the House of Representatives, and Dr.

Talaat Abdel-Qawi, President of the General Federation of Associations.



Ambassador Moushira Khattab, NCHR President, emphasized that the forum is one of the most important events. NCHR has been keen to organize annually since its inception. She hailed the vision of President

Abdel Fattah El-Sisi, and his support for the emerging human rights demarch, which requires the solidarity of all state entetities in a real, effective and transparent partnership with civil society organizations that play a pivotal role in dissilnating a culture supportive of human rights, protection, promotion and provision. and monitoring and monitoring implementation.

Khattab also stressed the importance of the forum as an opportunity to evaluate the achievements of the year of civil society and build on them and deal seriously and transparently with the challenges.

Minister Nevin Al-Qabbaj stated that various efforts and programs of the Ministry towards implemeting human rights, such as the right of children to protection from all forms of neglect, abuse, violence and exploitation, and the right to alternative family care, and the right of people with disabilities to rehabilitation and integration into society, and the right of the elderly to social, insurance and health care, and the right of poor and vulnerable families to integrated social protection, including cash support, safe housing, utilities, food support, and health insurance, and a right that includes female genital mutilation, early marriage, human trafficking, and other social and economic rights adopted by the Ministry.

Dr. Talaat Abdel-Qawi, President of the General Federation of NGOs, stressed the importance of the role of NGOs in the National Strategy for Human Rights, launched by President Abdel-Fattah El-Sissi in 2021 and his lauch of 2022 as the year for civil society institutions is a clear message for action and encouragement of NGOs, and that the year 2023 is to continue implementing current projects.



MPTariq Radwan, Chair of the Human Rights Committee of the House of Representatives, explained that civil society has played a major and active role in serving comprehensive development in its economic, social,

political and cultural aspects in light of the positive transformations that have taken place with the reform of civil work legislation and the adoption of the National Strategy for Human Rights.

Al-Qabbaj and Khattab sign a cooperation protocol between the Ministry of Social Solidarity MOSS and the National Council for Human Rights NCHR on "Promoting Human Rights provision and Capacity Building."

Nevin Al-Kabbaj, Minister of MOSS, and Moushira Khattab, President of the National Council for Human Rights(NCHR), signed a memorandum of cooperation to promote dissemination of human rights and capacity building of proffessionals, supporting the mission of MOSS in providing integrated care, development and social protection to deserving citizens without discrimination, as well as its role with regard to human rights, both Civil and political Rights a well as Economic Social and Cultural Rights with special attention to the rights of of children, women, the elderly, and people with disabilities.

The cooperation includes joint research, and holding conferences, seminars and workshops on basic human rights and public freedoms, study, coordination and addressing emerging issues, such as violence, murders and hate speech.

Training programs will be held in the governorates of Cairo, Alexandria, Port Said, Aswan, the Red Sea, and Minya.

The two parties stressed the importance of exchanging views on social issues affecting society and searching for the most appropriate human rights based interventions as well as dissemination of a culture supportive of the protection, promotion and provision of human rights. Nurturning a culture of respect for diversity, pluralism, and citizenship in accordance with the Egyptian constitution, the National Strategy for Human Rights, international human rights standards and Egypt's Vision 2030.

The protocol will be managed by a joint committee of representatives of the two parties that meets at least once a month, civil associations and institutions as partners, as well as the target, in order to ensure their implementation in a manner that guarantees human rights, as well as developing an implementation plan and, , preparing periodic progress reports , monitoring achievements as well as challenges, establishing mechanisms and financial commitments related to the provisions of the protocol, and overcoming any obstacles or problems facing the implementation of the provisions of the protocol.

A symposium at the National Council for Human Rights calling for the speedy issuance of the Medical Liability Law through a societal dialogue.

Within the framework of the National Council for Human Rights (NCHR) interest in protecting Egyptian Human Rights, and in connection with the right to health targeted by the National Strategy for Human Rights, NCHR organized a panel discussion entitled "The rights of doctors and patients between legislation and practice". Attendees included Dr. Ashraf Hatem, Chairman of the Health Committee in the House of Representatives and former Minister of Health, Dr. Hussein Khairy, President of the Egyptian Medical Syndicate, Dr. Gamal Abu Al-Surour, Professor of Medicine Al-Azhar and former president of the International Federation of Obstetrics



and Gynecology, counselor Mohamed Samra, Head of Appeal and Member of the Legislative Sector at the Ministry of Justice.

The panel discussion was opened by Moushira Khattab, President of NCHR. She emphasized that the right to health is a human right closely linked to human dignity, and health is closely linked to the human being. It is an enabler to live a healthy and dignified life. She called for societal dialogue to garner the views of all stakeholders concerning this law.

The panel discussion came out with a set of recommendations concerning the draft law regulating medical liability. The objective being to strike a balance between the rights of doctors and these of patients. Citizen's right to obtain integrated health care, and the doctor's right to carry out his/her work duties in an atmosphere of calm and reassurance conducive to improvement of work conditions in the health system, by reaching consensual articles regarding the following articles of the law:

- 1- Article 23: Codify the imprisonment penalty for doctors in the narrowest scope if there are criminal suspicions, work without a license, or intentional harm.
- 2- Article 23: Reconsidering the amounts of medical fines, as they are exaggerated
- 3- Adding an article related to the obligations of the medical facility with the imposition of penalties on the medical facility in case it fails to apply the required medical and professional standards.
- 4- Article 22: Cancellation of the phrase "without prejudice to any penalty provided for in any other, more severe law.."
- 5- Explicitly stipulating the formation of the sub-committees, their terms of reference, and the organization of their work, as they will actually be the body that will review the investigations



- 6- Article 12: The report issued by the Medical Liability Reporting Authority must be one of the documents required for litigation
- 7- No legal action is taken with the defendant until after the Supreme Committee issues its report (arresting the doctor, or detention pending investigation or renewal, ....)

With regard to the recommendations regarding training doctors and raising their competence, the recommendations stipulated that the goal is to provide quality medical education and specialized training at the best level in order to preserve the level of the Egyptian doctor to always be at the forefront.

- Advance vocational training and continuing medical education
- Develop unified clinical protocols regarding good surgical and medical practices, which are available in all hospitals and treatment centers and are binding on doctors, with the aim of standardizing medical practices in Egypt.

All practicing physicians must have insurance coverage against accusation of medical malpractice.

- There should be guidelines on dealing with patient complaints in all hospitals, with the ability to provide financial compensation if negligence or medical error is proven.
- Training physicians and increasing their awareness of medical registration and the principles of writing medical reports.
- Recommendations related to patients' rights, focus on:

Developing clear legal provisions stipulating the rights of the patient, such as informed consent, knowledge of his/her treatment plan, and non-disclosure of patient data.



- Providing approved written or visual materials to enlighten the patient about the illness, its consequencies, possible complications and treatment
- Availability of clear forms for informed consent and approval of medical and surgical interventions in a manner that is easy for the patient or his representative to understand.

### **Community awareness and the role of the media:**

- covering important issues objectively and avoiding intimidating public opinion against doctors. Balanced coverage of issues raised in the media, to avoid what is termed as "defensive medicine", meaning that some doctors may refrain from quick and effective intervention in complex cases whose treatment success rate is not great fearing reprisal. The negative result will accrue to the patient.
- Prepare guidelines on patient's rights and doctor's rights and responsibilities.
- Provide clear information to the police concerning doctors under investigation, accused of committing professional errors, or malpractice, and the circumstances that may restrict the freedom of the concerned doctor to investigate him and the possible duration.

The panel discussion was attended by Members of the Health Committee of the House of Representatives and the Senate, representatives of the Ministry of Justice, representatives of the Doctors Syndicate, the Ministry of Health, the General Authority of Teaching Hospitals and Forensic Medicine, and a group of law professors and doctors from various universities and medical bodies such as the universities of Cairo, Ain Shams, Alexandria and Al-Azhar, Mansoura, Zagazig, Damietta, military and police hospitals, in addition to civil society organizations participated in the panel discussion.

Khattab also stressed that President Abdel-Fattah El-Sisi's vision on Human Rights is the first of its kind in Egypt, and a unique initiative. She noted that President Sisi's vision is based on the fact that respect for civil, political, social, economic and cultural rights is closely linked to efforts to promote and protect Human Rights and Egypt's 2030 sustainable development strategy.

### The National Council for Human Rights joins the civil defense team in the case of the child "Shenouda"

Guided by the best interest of the child, the president of the National Council for Human Rights (NCHR) championed the defence of the rights of the child as as guaranteed by the constitution, Child code number 12 /1996 amended by Law 126/2008 and the UN Convention on the Rights of the Child. Khattab wrote an article published on 26 December 2022 by El Masry Alyoum a leading independent news paper. The article highlighted the right of the child to live in a family, biological or alternative and that removing a child from a family environment to place him in an institution is against the rights of the child according to international human rights standards. During its January meeting NCHR unanimously decided to ,join the defense team in the case of the child Shenouda in Case No. 73338 of 1976, which aims to reunite the child with his alternative family

NCHR issued a statement in early January for the need for the return of the child, Shenouda, to his family. And based on the competence of NCHR in the text of paragraph 17 of Article 3 of Council Law No. 197 of 2017, NCHR assigned its Legislative Committee to consider how to intervene in the judicial case and propose the necessary legislative and procedural amendments to be submitted to the concerned parliamentary and executive bodies, in addition to communicating and coordinating with all concerned parties until this case is resolved in a way that guarantees the best interest of Shenouda,

on the Rights of the Child, and minimum standards Child Rights.

NCHR affirmed that the human nature of this situation requires us to take action in the interest of the child to ensure his rights and implement the principles of mercy until the case is decided, which should not be an obstacle to the child's enjoyment of his right to the decent familyenvironment in which he is raised for a full five years.

In March 2023, the public prosecutor decided to return the child to his alternative family.

# Moushira Khattab at the Al-Azhar Symposium at the Book Fair: Egypt is making huge efforts to combat human trafficking

Moushira Khattab, President of the National Council for Human Rights (NCHR), shared a panel with Dr. Nazir Ayyad, Secretary General of the Islamic Research Academy, and Professor Mahmoud Abdel Rahman, member of the Media Center of the Sheikhdom of Al-Azhar, in a symposium organized by Al-Azhar Al-Sharif held at its pavilion at the Cairo International Book Fair, "Human Rights and Combating Human Trafficking Crimes", Khattab declared that Human trafficking is the modern form of slavery, amd that 30% of the victims of human trafficking, are women. She added that men, children and youth could also, be victims, from nationals, immigrants or refugees.

Ambassador Khattab addressed that human trafficking, is considered a crime against humanity, at a time when the world has made great achievements, upholding Human Rights as the standard or yardstick. She explained that Egypt is one of the leaders of the global movement for Human Rights, and it stems from one thing, which is the right to dignity because we are all born equal in dignity, while the crime of human trafficking destroys the human sense of dignity, and represents a violation of Human Rights. Khattab commended the efforts of the Egyptian state and



the Public Prosecution. Both played tangible role in monitoring complaints, or violations. They spared no effort to assist and protect potential victims. Such efforts lead to reduction of the crime of human trafficking.

Ambassador Khattab highlighted the role of NCHR in combating the phenomenon of human trafficking, and the role of the complaints system, which receives all complaints and refers them to the competent authorities. She added that and there is coordination among many state agencies to provide protection for victims and in particular refugees.

The President of NCHR also appreciated the signing and launch of the Human Fraternity Document, which was inaugurated by the Grand Imam, Dr. Ahmed Al-Tayeb, Grand Sheikh of Al-Azhar, and Pope Francis, Pope of the Vatican.

Dr Nazir Ayyad cited Al-Azhar Foundation as one of the national institutions that cooperates and put its weight behind fighting this crime. The Foundation is keen to foster its role in spreading religious awareness in a practical and professional manner to curb such a crime. He also praised the Universal Declaration of Human Rights, and the document of citizenship in the cera of the Prophet (PBUH), as being achievements of the modern era, as well as the document of freedoms and the document of brotherhood.

### Khattab: Promoting a culture of tolerance provides a supportive environment for the respect and enforcement of Human Rights

Ambassador Moshira Khattab, President of the National Council for Human Rights (NCHR), received a delegation headed by Mr. Ahmed bin Muhammad Al-Jarwan president of the Global Council for Tolerance and Peace, and Professor Mahmoud El Meitinii president of Ein Shams University. Welcoming the guests, khattab mentioned that promoting a culture of tolerance is imperative to nurture environment supportive of respect, protection, promotion and enforcement of Human Rights, stressing that the nexus between tolerance, peace and Human rights is an important relationship. She asserted that Tolerance is an essential pillar of human

rights, as it is the basic building block of the Human Rights system in any community.

Khattab explained that tolerance corresponds to the right to enjoy all human rights without discrimination, considering that non-discrimination is a fundamental principle and an integral pillar upon which all Human Rights are based.

Mr. Ahmed bin Muhammad Al-Jarwan and Moushira Khattab agreed to, jointly develop Human Rights based school curriculae to teach children tolerance, Human Rights and respect of diversity. It also provides for training government employees and private sectors to ensure and uphold same values of tolerance and peace.

Mr. Ahmed bin Muhammad Al-Jarwan emphasized that the NCHR in Egypt succeeded in playing an important role in consolidating Human Rights values and promoting its culture, despite the challenges that the Arab region has gone through during the past few years. He said that the Global Council for Tolerance and Peace believes that spreading the values of tolerance implicitly contributes to the dissemination of a culture of Human Rights, as work to spread the culture of Human Rights and its principles includes the consolidation of the values, principles and culture of tolerance.

The protocol of cooperation affirms the desire of both parties to enhance means of cooperation in order to achieve peace, spread the values of tolerance and a culture supportive of Human Rights, and their fullenjoyment. The protocol also provides for cooperation to build capacities and promote a culture of Human Rights and of tolerance in order to achieve the goals of peace.

The NCHR, in cooperation with the Global Council for Tolerance and Peace, held a symposium entitled "Mechanisms for spreading the values of tolerance, world peace and human rights" in the context of signing a cooperation protocol between the two councils with the aim of coordinating



efforts in areas of work that contribute to spreading the values of tolerance and peace regionally and globally. The discussions and interventions of the

attendees concluded that it is necessary to benefit from this cooperation in raising societal awareness of the values of tolerance and peace, and the concepts of Human Rights, and the need to work to unify all societal efforts and capabilities to spread that culture at various levels and start with the family through the school and religious, media and educational institutions at the level and practice on the ground. This requires working to integrate the values of tolerance, peace, and Human Rights into school curricula, community programs, and media content to combat extremist ideology and refute hate speech.

Dr. Mahmoud El-Metini, President of Ain Shams University, and Dr. Hisham Azmy, Secretary General of the Supreme Council of Culture, participated in the symposium on behalf of the Minister of Culture, Vice-President of the British University, Vice-President of October 6 University, members of the NCHR, representatives of the Ministries of Environment, Finance, Education, Youth and Sports, Manpower, Planning and Economic Development and representatives of the universities Fayoum, Al-Azhar, Canadian, and Misr for Science and Technology, in addition to representatives of the concerned and relevant societal sectors, all participated in this event.

The National Council for Human Rights (NCHR) held a round table discussion entitled "The Role of the Media on Introducing and Disseminating the National Strategy for Human Rights", the roundtable discussion is one component of the activities of the project "Supporting"



Efforts to Enhance Political Participation and Democracy Mechanisms in Egypt", which is implemented by NCHR in cooperation with the Swiss Embassy in tCairo.

A selected group of writers, journalists, media figures, and experts specialized in the field of Human Rights participated in the table.

The work of the round table began with an introductory session, moderated by Dr. Magdy Abdel Hamid, Project Director, during which Ambassador Dr. Mahmoud Karem, Vice President of the NCHR, spoke, indicating that NCHR believes that the success of the strategy in achieving its targeted results will only be achieved effectively through the continuation of the participatory approach that follow up at the stage of preparing the document, in the process of follow-up, evaluation and implementation as well as in cooperation between the concerned authorities.

The first session was moderated by journalist writer Hisham Younis, and dealt with the media professionals' vision of the National Strategy for Human Rights, where the participants discussed the evaluation of the strategy in the first year to stand on common ground between the various visions and political, intellectual and cultural currents in order to reach specific recommendations that can be submitted to state institutions regarding the implementation of the strategy in the few years coming.

The second session, which was moderated by Dr. Amani Al-Taweel, advisor to Al-Ahram Center for Political and Strategic Studies, dealt with the formulation of proposals and ideas on the role of the media in disseminating the National Strategy for Human Rights.

The Training and Capacity Building Department of the National Council for Human Rights (NCHR) concluded a training course on "Human Rights Basics" for workers at the General Office Ministry of Social Solidarity.

The training course, which lasted for two days, was inaugurated by Ambassador Mahmoud Karem, Vice President of NCHR, Dr. Ismail Abdel Rahman, General Supervisor of the Training Department and member of



NCHR, and Dr. Ayman El-Sayed, Advisor to the Minister of Social Solidarity.

Karem stressed the importance of intensifying national efforts to build capacities and train state workers in order to enhance the Human Rights march in Egypt, and to consolidate and implement its concepts and culture, stressing that this cannot be done without integrated cooperation with all ministries and government agencies to consolidate the link to reach the desired primary goal, which is spreading and promoting a culture of human rights.

Dr. Ayman El-Sayed commended the role of NCHR played in supporting and spreading the culture of human rights as an independent national institution that seeks to extend human awareness of their rights and how to enhance them - hoping that the Ministry and its employees will have full knowledge of the basics of Human Rights and public freedoms and how to examine the social phenomena that appear in Egyptian society. and deal with it.

The two-day training course dealt with the nature and origin of Human Rights, the International Bill of Human Rights, the mechanism for dealing with citizen complaints received by NCHR, the definition of the National Strategy for Human Rights, the Convention for Persons with Disabilities, combating discrimination, and the Human Rights crisis at the international and national levels. This course represents it in raising their abilities and knowledge towards the concepts of Human Rights, which have become an integral part of their daily work.

Khattab chaired and moderated the side event, vice chair of CRC and of ACERWC gave their insights. The side event built on the outcome of



the International conference held in Addis Ababa and organized by Africa Child Policy Forum.

### The National Council participates in the meetings of the High Commissioner for Human Rights in Geneva

The National Council for Human Rights (NCHR) participated with a high-level delegation in the meetings of the 137th session of the Human Rights Committee in Geneva, Switzerland, which considered state party reports presented by Egypt, Panama, Peru, Sri Lanka, Turkmenistan and Zambia, on national efforts towards implementation of the provisions of the International Covenant on Civil and Political Rights.

Ambassador Moushira Khattab, NCHR president, presented a shadow report brepared the evaluation of NCHR for the report submitted by the Standing Committee on Human Rights and the state of civil and political rights in Egypt during the period from November 2020 to September 2022 before the members of the committee.

Ambassador Moushira Khattab confirmed that NCHR touched the existence of a political will to enhance the state of civil and political rights, by launching the National Strategy for Human Rights and reshaping the committee of the Presidential Pardon and working on the release of the prisoners and their reintegration and rehabilitating them, as well as the launching by the state a National Dialogue open to the entire spectrum of political currents, which constitutes a base on which can be built on to support the state of civil and political rights.

She added that the Egyptian state is dealing with concern with Human Rights issues, and this is evident in the formation of the new NCHR, which adheres to the Paris Principles, and in which women occupy a predominant percentage, as a woman heads for the first time NCHR since it was established, pointing to the interest of NCHR in receiving citizens' complaints n the field of Human Rights through the complaints system and that it touches the incresing interest of citizens in it, which is a sign of their confidence in the national mechanisms of human rights. It also pointed to



the fruitful cooperation between the complaints system with the Presidential Pardon Committee, in addition to NCHR ten visits to the reform and rehabilitation centers within 10 months, which is an unprecedented percentage in the history of NCHR, as well as preparing NCHR a training guide to visit the detention centers based on the Nelson Mandela rules for treatment of inmates.

At the end of the Ambassador Moushira Khattab presentation of the report of NCHR, the members of the committee asked a number of questions that the chairman and a number of members participated in.

During his response to the questions of committee about the role of the NCHR, Ambassador Mahmoud Karem, Vice -President of the NCHR, pointed out that the National Strategy for Human Rights created a new reality and reflected the state's pledge to provide the legal file a special priority, stressing the great role that NCHR monitors the human rights situation in Egypt and informs about it, stressing that reports of NCHR reflect the reality, as it plays a pivotal role in reviewing the legislation and its consistency with international human rights standards. He pointed out that NCHR monitors the implementation of the National Strategy and talks about right and wrong and open to cooperation with civil society organizations, pointing to the state's celebration of civil society and allocating a full year to take care of the issues of civil society.

Ambassador Karem said that NCHR was the first to form its recommendations for National Dialogue, as the complaints system of NCHR worked positively with the Presidential Pardon Committee, pointing out that matters in Egypt are developing quickly for the better, especially related to Human Rights issues, and stressed that Egypt respects the separation of powers, stressing independence The Judiciary and that there is no interference in the work of the judiciary, stressing that the openness of NCHR to cooperation with international partners and that it is doing its best to improve the conditions of Human Rights.

A number of members of NCHR responded to the committee's questions regarding the independence of the judiciary, stressing that the Egyptian



judiciary has a well documented history, as it was established in the thirties of the last century and is independent and stable throughout history according to the ruling regimes and that the executive authority is not entitled to isolate the judiciary where the Judicial Authority law only allows referral to validity in the case the judge committed a crime that violates his neutrality or a crime against honor. With regard to the type of study obtained by judges and lawyers, both of them graduate from law colleges.

The members of NCHR explained that Egypt has 106 political parties, which is a very large number compared to major western countries with two or three parties, and that the 1977 political parties law was amended several times, the most important amendement of which is the establishment of procedures for establishing a party, as the number required to establish a party was established as o ly fifty Egyptian citizens, a small number compared to a population of 110 million people. It is only forbidden to establish parties that are based on military militias, obtaining financing from abroad or being a branch of a party in a foreign country.

Participarw in the discussion, were members of the delegation, Dr. Wafaa Benjamin, Professor Samira Luka, Professor Saeed Abdel Hafez, Professor Abdel -Gawad Ahmed, and Professor Mahmoud Bassiouni.

meetings and push to strengthen the powers of NCHR so that it can play its role more effectively in monitoring national efforts that translate the National Strategy for Human Rights into tangible results and practical steps.

Ambassador Gilmore congratulated Egypt on its achievements in the field of Human Rights, particularly the promotion of women's rights and religious freedoms. The European official also affirmed the European Union's interest in economic, social, and cultural rights, just as it is in civil and political rights. He also welcomed NCHR preparation of a training manual for visits to prisons and rehabilitation centers in line with Human Rights standards for the treatment of inmates in detention centers to ensure that they obtain their basic rights.

Gilmore also welcomed the re-formation of the Presidential Pardon Committee and work on the release of prisoners, their reintegration and rehabilitation, as well as the Egyptian state's announcement of opening the way for a national dialogue inclusive of all political currents.

For her part, Moushira Khattab praised the existing cooperation with the European Union.

## The National Council for Human Rights reviews its experience at a high-level international conference for Grievances Bureaux in Morocco

Dr. Walaa Gad Al-Karim, member of the National Council for Human Rights (NCHR), participated as representative of NCHR at the high-level international conference for the Secretariat of Grievances and the Umbodsman institutions, which was hosted by the Royal Academy in the Moroccan capital Rabat on February 28, 2023 under the high patronage of His Majesty King Mohammed VI, headed by Mohamed Ben Alilou the mediator of the Kingdom vice president of the Francophone Imbodsman Association.

The conference was held at the occasion of the 20th anniversary of the founding of the Mediator (Moroccan Grievances Bureau) under the title "Ensuring the developmental dimension of the Human Rights activity in public policies."

The international conference witnessed a high-level presence of leaders and heads of the National Human Rights Institutions (NHRI) and secretariats of Grievances Bureaux from several European, African and Arab countries, in addition to experts and international officials from various networks and



Grievances Bureaux from the Francophone and Europeans alliances. The conference witnessed in-depth discussions on the roles of NHRIs and

Grievance Bureaux in accordance with the relevant United Nations General Assembly resolutions.

For his part, Dr. Walaa Gad Al-Karim, member of the NCHR and head of NCHR Complaints System, reviewed in a working paper that reflects the vision of the National Council for Human Rights regarding the role of national institutions in achieving justice, fairness and the rule of law, the roles played by the NCHR in Egypt during the previous period in dealing with complaints and grievances related to Human Rights violations, the successes that was achieved through investing the President's initiatives to use his authority in the presidential amnesty for a large number of prisoners, and the inclusion of demands related to the main challenges to enhance human rights in the axes of the National Dialogue Initiative launched in April 2022.

The paper submitted by Dr. Gad Al -Karim also touched on the features and indicators that reflect the compatibility of the performance and system of the NCHR with international principles and standards that guarantee independence, efficiency and empowerment of the institutions of the grievances and NHRIs, whether Paris principles or the General Assembly of the United Nations resolutions.

Gad Al-Karim emphasized that the Egyptian constitution and the NCHR law No. 197 of 2017 ensure the participation of NCHR effectively in enhancing the implementation of Human Rights obligations and achieving justice, fairness, and the rule of law.

The NCHR member added in his paper that the current formation of NCHR is based on the historical heritage of the previous formations

Moushira Khattab, welcomed Dr. Reda Hegazy, Minister of Education and Technical Education at the headquarters of the NCHR. The meeting with the Students's Union of the Schools of (SUSR), centered around the role of youth in implementing the national strategy for human rights.

Dr. Reda Hegazy welcomed the attendees, appreciating the efforts made by the Ambassador, Moushira, President of NCHR. Hegazy hailed the bilateral cooperation with NCHR with a view to implementing the national strategy for human rights.

The Minister stressed that the reform of education is the state project, pointing to the Ministry's efforts to develop curricula, on an ongoing basis, providing school libraries with books that enhance human rights, and call for rejecting violence and extremism, and seeking to form a different educational environment that does not allow extremism to know its path to our educational institutions.

The Minister pointed out the inclusion of the curricula of the Arabic language, religious education and national education, which deals with human rights and citizenship, as well as confronting the phenomenon of bullying, pointing to the issuance of a periodic directive circular for international schools and exemplary official schools directing them to adhere to the holding of national identity exams (Arabic language, religious education, and national education) and for the directors of these material subjects at the level of the Ministry to set these exams for the second semester to enhance interest in these materials.

The Minister also stressed the Ministry's interest in promoting awareness at the level of directorates and educational departments in the nature of persons with special needs and the best way to deal with them and to facilitate their daily dealings, their participation and integration as an full partner in the society.

The Minister pointed out that the ministry, in cooperation with NCHR, reviewed the curricula from the Human Rights perspective to clear textbooks from any content which may contradict these rights; In the hope of raising a generation characterized by full awareness of its correct values, with the aim of developing curricula as a major tool to establish Human

Rights values and spread its culture.

The Minister stressed the keenness to form elected student councils in a competitive context, through which the student learns the values of participation, dialogue, discussion and tolerance, the values of participation and belonging, and enhance the school status because it is the natural place to learn.

The Minister also pointed to cooperation with the Ministry of Culture in promoting the strategy of building the Egyptian person, through the activities and events organized by the Ministry by specialists in all areas of creativity in discovering and refining the skills of talented people in the fields of arts and literature in the stage of young people and youth, which helps to create a conscious and enlightened generation.

In her speech, the Ambassador, Moushira Khattab, welcomed the attendees, stressing that Human Rights are a way to solve incurable problems and are the most important issue in the world, stressing the extent of the attention attached This meeting is within the framework of activating this strategy, spreading awareness of human rights, and addressing human rights problems.

The Ambassador, President of the NCHR, said: "During this meeting, we are pleased to listen to the students present in NCHR and follow up on the extent of development in education in the interest of students and the reflection of that development in their favor and we can learn about practical simulation by listening and discussing students, whether questions or opinions, and seeking students' opinion about the comparison between the existence of clear curricula for human rights or extracurricular activities, stressing that the duty is completely related to rights and everyone must be committed to the application of rights with duties". She also praised the students of SUSR present from the participating governorates, describing them as ambassadors of human rights in their governorates, representing 25 million students from the strongest and most important population segment.

The President of the National Council for Human Rights raises the alarm concerning rising rates of "Caesarean section" and calls for tightening the implementation of conventions in order to preserve the health of mothers

On the occasion of International Women's Day:

Moushira Khattab, President of the National Council for Human Rights (NCHR), expressed her concern at the high rates of cesarean delivery in Egypt. Khattab flagged the medical responsibility towards the health and well-being of the recipients of the medical service, as well what appears to be the transformation of a great and dignified profession into areas that may appear gray.

Khattab explained that the high rates of resorting to caesarean section is a decision that may be taken by the doctor, or by the woman who is about to give birth, but in both cases there is a great responsibility on the doctor, to educate the woman about the consequences and potential negative effects on her health and the health of her newborn. She added that important rights are threatened by this development. As it constitutes a violation of the right to obtain information, the right to obtain the highest possible level of advice and medical service, and empties women's right to the freedom to make decisions based on correct information related to and affecting their health. It also constitutes a violation of the right for the best interest as a



primary consideration in any decision or procedure related to the child. The right of the child to enjoy the highest possible level of physical and psychological health, and the right to development and survival by obtaining the highest possible level of service and health care.

The President of NCHR indicated that such operations represent violence against women and negligence on the part of the doctor

Khattab praised the attention given by Dr. Khaled Abdel Ghaffar, Minister of Health and Population, to this phenomenon and the speed of action through several directives, which would work to reduce the unjustified increase in the rates of caesarean section deliveries, in return for increasing the demand for natural deliveries, in the framework of preserving the health of the mother and fetus. and improving the general health of citizens.

The round table discussion amidst the celebration of the Association of Fellows and Members of the British Royal College of Obstetrics and Gynecology in Egypt, entitled "Contemporary Health Challenges", coinciding with International Women's Day, which falls on the eighth of March, in the presence of Dr. Wafa Benjamin, member of NCHR and Ms. Nihad Abu Al-Qumsan is a member of NCHR, members of the House of Representatives and the Senate, representatives of the World Health Organization, representatives of the United Nations for Women, the United Nations Population Fund, and UNICEF, members of the Royal College of Obstetricians and Gynecologists working in Egypt, in addition to representatives of civil society and the media.



National Council for Human Rights hoted by the Senate to present the results of its participation at the consideration of Egypt's 5<sup>th</sup> periodic report on the implementation of the International Covenant on Civil and Political Rights in Geneva

Moushira Khattab, President of the National Council for Human Rights (NCHR), eaded a delegation of members of NCHR to the Committee on human Rights at the Senate, reviewed the important outcome of NCHR participation in the meetings of a United Nations committee on Civil and Political Rights during a meeting organized by the Human Rights and Social Solidarity Committee of the Senate, chaired by Representative Eng. Mohammed Heiba.



Moushira Khattab said that the presentation of Egypt's 5<sup>th</sup> periodic report on the implementation of civil and political rights after a delay of more than seventeen years is a positive step in the right direction. It indicates a new resolve to implement its international commitments in order to advance the rights of the Egyptian citizen. She pointed out that the participation of the Egyptian official delegation, headed by Counselor Omar Marawan, Minister of Justice, was very representative and characterized by a multiplicity of disciplines. Khattab praised the contributions of the members of the NCHR who participated in the closed session held by the committee to listen to the evaluation of NCHR, and appreciated the efforts they made during the session and in the contacts and interviews they conducted on the sidelines of the meetings. She presented the results of the interviews that took place on the sidelines of the session with officials of the Office of the High Commissioner for Human Rights and the Commission of the European Union, and that the interviews reflected an appreciation for the role of NCHR as the independent national institution established under the Paris Principles. She also appreciated the speech of constructive cooperation with the Egyptian Parliament in its two chambers, and stressed the importance of the House of Representatives' decision to review the Criminal Procedure Code, which will hopefully guided by the National Strategy for Human Rights.

Chair of human rights committee at the Senate Muhammad Heiba praised the performance of NCHR during the Geneva meetings and, which will reflect positively on the development of the human rights system within the framework of the national strategy.

Moushira Khattab explained that the participation of the delegation of the NCHR, as an independent national institution, was rich and that extensive dialogues took place with a wide range of international experts, international organizations and representatives of important regional organizations, led by the European Union. She said that NCHR reviewed in Geneva the progress achieved in its "complaints office mechanism", which is currently being developed within the framework of a cooperation program with the European Union. Dr. Mahmoud Karem, Vice President of



NCHR, also touched on the nature of inquiries and questions that are directed to Egypt in those high-level international forums. Ambassador

Fahmy Fayed, Secretary General of NCHR, spoke about the recent developments in the work of NCHR,. NCHR members, Dr Samira Louka, Dr. Ismail Abdel Rahman, Mr Abdel Gawad Ahmed, Dr. Mohamed Mamdouh, and Mr Ezzat Ibrahim, reviewed various aspects of the Egyptian participation in the international meetings in Geneva. A lengthy dialogue took place between members of the Senate Committee and members of NCHR to discuss all aspects of participation in order to come up with recommendations on how to follow up on the implementation of the concluding observations of ICCPR.

# The National Human Rights Council welcomes the decision of the Central Bank to authorize mothers to open bank accounts for minor children

The National Council for Human Rights (NCHR) appreciates the decision of the Central Bank of Egypt, which includes the possibility for a mother to open accounts in the name of her minor children or to link savings accounts to their names, as required by Section (3) of the Money Conservancy Provisions Act promulgated by Legislative Decree No. 119 of 1952, as part of the continuing efforts of the state to facilitate banking transactions for women, and to remove all difficulties or restrictions that may prevent women from obtaining banking services of any kind,

NCHR Economic Rights Committee considers the decision to support women's economic rights and economic empowerment, as well as promoting financial inclusion in society, in order to achieve the goals of the National Human Rights Strategy and Egypt's vision for sustainable development 2030 by achieving gender equality in access to banking services, without discrimination, increasing women's contribution to the domestic product and activating their important role in society in his outfit.

This decision taken by the Central Bank intervenes within the framework of a control of the various practices applied by certain banks in the matter, in particular the absence of the right of the mother to open accounts in the name of her minor children or to bind savings accounts in their names, or limiting the mother's transactions to gift accounts only.
