# Report of the monthly meeting of the Regional Council for Mental Health (2)

- The Regional Council for Mental Health (2) in Alexandria held its meeting No. 129/2023 on Monday, 5/22/2023, at the Council's headquarters in Abu Qir General Hospital.
- All members attended the meeting, with Dr.'s apologies. Soha Abdel Latif / Professor of Psychiatry, Alexandria University.
- First, Dr. Kamal Al-Fawal, Chairman of the Council, welcomed the members, especially Dr. Ashraf Saad Galal/Captain of the Governorate Doctors Syndicate, who is attending council meetings for the first time.
- 1 He made a brief explanation of the council's tasks, and that the most important goal is "correct treatment and proper treatment," and that among the council's powers is to inspect public and private hospitals within its jurisdiction (6 governorates), the difference between compulsory and voluntary patient admission, and the mechanism Presenting the cases to the Council in Cairo.

# C- Care nd inspection committees:

Include were 16 facilities during the month of April with the participation of a complaint researcher at the Patient Rights Care Department in the governorates of Alexandria - Gharbia - Beheira.

The following are the most important observations:

1- Another inspection of the Future Convalescent Home (private) in Alexandria Governorate, given that this is the third visit that takes place without the presence of a doctor or technical director, which is considered a final warning to the institution. The Council took a

decision to notify the free treatment, which has judicial authority in this regard.

- 2- Re-evaluation of the Motmana Psychiatric Center in Alexandria (private).
- 3- Green Valley Psychiatric Center in Beheira (private).

### Other notes:

- The number of doctors for inspection has been increased from 31 to 35 doctors.
- The number of independent evaluation doctors was increased from 56 to 58.
- It was not possible to participate in the group breakfast for members of the Regional Council for Mental Health 2.

# Recommendations:

- 1- Discussing the possibility of sending the report of the medical responsibility symposium to the members of the Regional Council for Mental Health 2, in which the former head of the Alexandria Doctors Syndicate, Mohamed Farid, participated.
- 2- Discussing contacting the Ministry of Health to solve the problem of the broken elevator in Abu Qir General Hospital for years, which negatively affects patients and disrupts the activities of the Regional Council for Mental Health 2.
